We will be meeting at our same time 7pm, and will enjoy the presentation, "Imprisonment, Trial, and Execution of Lincoln Conspirators" by Mark Grim, who will focus on the events after John Wilkes Booth's death, and the capture of the other conspirators, and their trials and executions.

Mark Grim is a graduate of the US Navy Judge Advocate Generals School, retired attorney, an US Marine Corps Colonel. He has also been known to portray Brevet Major General John F. Hartranft, who was known for reading the death warrant to the Lincoln assassination conspirators. Hartranft had also been awarded the Medal of Honor for his action at the Battle of Bull Run.

Featured Regiment - 12th New Jersey

The 12th New Jersey Infantry, also known as the "Buck and Ball" regiment, was known for their gallantry in combat. The regiment was organized in the summer of 1862 in Woodbury, and was attached to the Army of the Potomac in September. The regiment was engaged at Chancellorsville, and later known for its role in the defense of Union lines at Gettysburg on the second and third days of battle. The regiment was mustered out on July 15th, 1865. Sergeant-at-Arms Craig Costigan's second great grandfather, Thomas Costigan, immigrated from Ireland in 1862, and soon enlisted in the 12th New Jersey.

Issue #1 - April, 2024

Civil War History of April

April 6 - 7, 1862, Battle of Shiloh: In early April, as the Union Armies of the Tennessee and Ohio, commanded by General Grant and Buell, march south to Pittsburg Landing in hopes to severe the Confederacy into two. Previously, General Grant had vitally captured the forts of Donelson and Henry, crimpling Confederate transportation and communication. Confederate General Albert Sidney Johnston, moved his men to the River and with the help of generals Braxton Bragg, engaged the Union troops. During the battle, General Johnston was mortally wounded, and after the battle had concluded it had been the most deadly event in US History.

April 12th-15th, 1861, Fort Sumter: Confederate General PGT. Beauregard fires upon Fort Sumter, in Charleston Harbor, South Carolina, officially starting the Civil War. Lincoln, three days later, calls for 75,000 volunteers to suppress the rebellion.

April 12th, 1864, Massacre at Fort Pillow: Confederate cavalry commander, Nathan Bedford Forrest, brutally murder 300 prisoners of war at Fort Pillow, most of whom belonged to the United States Colored Troops.
